EFFECTIVE	REVISION
For bills rendered on or after October 1, 2008	October 1, 2008

Purpose:

To provide revenue for patron's electric service and capital from the patrons. In compliance with cooperative principles and the Cooperative's by-laws, revenue for electric service is equal to the cost of service provided. All monies in excess of the cost of providing electric service is capital, at the moment of receipt, and will be credited to each person's individual capital account.

Availability:

Available in all territory served by the Cooperative, subject to the Cooperative's established service rules and regulations.

Applicability:

At the member's request, for all churches of the Cooperative who fully participate in the Cooperative's automated technology programs, who use electricity as their sole source of fuel, and who do not elect to receive service under other church rate schedules offered by the Cooperative. To qualify for this rate, the measured load must be less than 30kW and monthly energy usage less than 3,000 kWh.

Type of Service:

Single-phase or three-phase, 60 hertz, at available secondary voltages.

Minimum Charges:

The minimum monthly charge under the above rate shall be \$25.

Power Cost Adjustment:

The rates shall be increased or decreased subject to the provisions of the Cooperative's Wholesale Power Adjustment Schedule PA-8.

Three-Phase Service:

Three-phase service is available to churches with prior approval of the Cooperative. Members receiving three-phase service will be billed a monthly charge of \$12.50 in addition to all other charges.

Point of Delivery:

The Cooperative reserves the right to select each meter delivery point.

Terms of Payment:

The rates are net, the gross being five percent (5%) higher. In the event the current monthly bill is not paid on or before the "PAST DUE AFTER" date as indicated on the bill, the gross rates which are 5% higher, shall apply.
