Availability:

Available from existing distribution lines in all territory served by the Cooperative, subject to the Cooperative's established service rules and regulations.

Applicability:

Applicable only to outdoor lighting by ballast operated vapor lamp fixtures, either mercury (MV), high pressure sodium (HPS), or metal halide (MH) and poles conforming to Cooperative specifications. Service will be rendered only at locations where extension of lines will not exceed 150 feet per pole and secondary voltage is available. Further, service will be rendered only at locations that, solely in the opinion of the Cooperative, are readily accessible for maintenance.

Conditions of Service:

- (1) The foregoing monthly rate charges are based upon overhead service provided on existing standard wood poles. When separate, additional poles, or decorative poles for underground fixtures are required in order to furnish service hereunder, the member shall pay in advance the applicable contribution in aid of construction for each such pole. The contribution required for a standard wood pole will be \$300.00. The contribution required for any poles other than a standard wood pole will be determined at the time of installation.
- (2) When underground service is provided hereunder, in addition to all other charges contained herein, the member shall pay in advance a \$200.00 contribution in aid of construction for each fixture. Further, where paving or other obstructions exist, the member also will be required to perform all trenching, install duct furnished by the Cooperative, back fill, and complete the paving to the mutual satisfaction of all parties concerned.
- (3) The member may be required to reimburse the Cooperative for any maintenance work which is required because of vandalism.
- (4) The Cooperative may not be required to install more than four standard luminaires on new standard poles set exclusively for the purposed of rendering off-street security lighting in commercial or industrial developments.
- (5) Members applying for service hereunder in excess of 150 feet from existing lines, or desiring underground service or non-standard poles, may be required to execute a written contract with the Cooperative in advance of the Cooperative extending such service.
- (6) Relocation of service at the member's request shall require full payment from the member for charges hereunder for the remainder of the contract period and the execution of a new contract.
- (7) The original term of service (contract period) hereunder shall be one year, unless otherwise stated in a written contract for service between the member and the Cooperative. Should the member request termination of service, full payment from the member for charges hereunder for the remainder of the contract period shall be required.

Terms of Payment:

These rates are net, the gross rates being five percent (5%) higher. In the event the current monthly bill is not paid on or before the "PAST DUE AFTER" date as indicated on the bill, the gross rates, which are 5% higher, shall apply.
